

Recommended LGBTQ Children, Youth, and Families Cultural Competence Tools, Curricula, and Resources

This synthesis recommends publicly available resources that can support workforce development in child-, youth-, and family-serving systems (e.g., schools, healthcare, child welfare, homelessness, juvenile justice). Resources are intended to support more competent practice and affirming, inclusive services and supports for lesbian, gay, bisexual, transgender, and questioning (LGBTQ) children, youth, and families.

The resources in this synthesis align with 10 standards of care described in *Improving Emotional and Behavioral Outcomes for LGBT Youth: A Guide for Professionals* (Fisher, Poirier, & Blau, 2012). These standards provide a framework for improving outcomes and the well-being of LGBTQ young people. The second resource in the synthesis, a strategic planning tool, provides an overview of standards in these ten areas:

This synthesis excludes websites, resources not accessible online, and webinars, unless printed resources are limited in a particular topical area. As a workforce development tool, this synthesis is not primarily intended to share direct resources for families and youth themselves. However, given the importance of systems providing LGBTQ children, youth, and families with access to such resources as a strategy to provide inclusive, responsive services and supports, several resources for families and youth are included at the end.

The synthesis begins with the American Institutes for Research’s planning tool and then organizational/individual assessments. These are followed by curricula for in-person trainings and for online learning modules. Professional practice standards, guidelines, briefs, and tips are then shared, organized by system or topical area. The synthesis includes a summary of state policies, and concludes with examples of direct resources for families and youth.

Reaching Higher: A Curriculum for Foster/Adoptive Parents and Kinship Caregivers Caring for LGBTQ Youth Facilitator Guide (2014, National Center for Child Welfare Excellence)

This [curriculum](#) was developed to help foster, kinship, adoptive, and guardianship parents enhance their skills in providing direct care for LGBTQ (lesbian, gay, bisexual, transgender, and questioning) youth. Designed for full-day facilitation, the modules in this curriculum will provide participants with information about the importance of improving child welfare practice with and care for LGBTQ youth, including the impact and scope of LGBTQ youth in the foster care system; help participants to assess their own values and beliefs to identify strategies for balancing personal views with professional or caregiver responsibilities; and increase competency in using accurate and culturally appropriate terminology. The curriculum includes nine modules:

Child Welfare Curriculum	<p>Reaching Higher: Increasing Competency in Practice With LGBTQ Youth in Child Welfare Systems (2014, National Center for Child Welfare Excellence)</p> <p>This curriculum was developed to improve service delivery for LGBTQ youth and their families. The curriculum was designed to increase the competence of all types of child welfare staff, such as those providing child protection services; foster care, kinship care, guardianship, and adoption services; and permanency planning and transitional living services. The curriculum is meant to enhance the skills of child welfare staff working with LGBTQ youth, regardless of where the youth reside or the legal status of the case.
